REQUEST FOR BID

MATHESON PARK COLVERT REPLACEMENT AND ADDITION OF BOX DRAIN.

1. INTRODUCTION

The Town of Taylorsville is seeking bids for the replacement of 40-foot culvert and addition of a box drain at Matheson Park. The box drain will have to be offset from a previous sewer line placed. Culvert will need to be 48-inch double wall plastic and needs to be supported over previous sewer line placed. This Request for Bid (RFB) is not to be construed as an offer, contract, or commitment of any kind; nor does it commit the Town of Taylorsville to pay any cost incurred by the bidder in the preparation of its bid.

2. SUBMITTAL DEADLINE

3. CONTRACT AWARD

Bids shall be considered by the Town of Taylorsville staff and board based on cost of procurement, contractor integrity, compliance with public policy, record of past

performance, financial and technical resources, and the best overall value to the Town of Taylorsville. The Town of Taylorsville reserves the right to accept or reject any or all bids, waive formalities in the bidding, waive irregularities in any or all bids, and make a bid award deemed to be in the best interest of the Town of Taylorsville.

4. SUBMITTAL REQUIREMENTS

All bids shall be submitted by 12:00 P.M. on November 27, 2023. Bids can be submitted at Town Hall or by email.

5. REQUIREMENTS AND SPECIFICATIONS

All bidders must have a minimum automobile and liability insurance policy of \$1,000,000 per occurrence as well as worker's compensation that meets the state's statutory requirements. A copy of the current policy must be attached to the bid unless the Town of Taylorsville already has a copy on file.

Bids need to be broken down into labor cost and material cost.

Work requested:

Replacement of 40-ft culvert with 48-inch double wall plastic culvert and supported over previous sewer line placed.

Addition of a Box Drain. Box drain will have to be offset due to a previous sewer line that was placed.

Work must be completed as soon as possible.
