REGULAR TOWN BOARD MEETING

May 24, 2005

Present: Mayor Guy Barriger, Commissioner Glenn P. Deal Sr., Commissioner George Holleman, & Commissioner Bob Phillips

The regular meeting was opened for business by Mayor Barriger at 5:00 p.m.

Commissioner Phillips gave the invocation. The Pledge of Allegiance followed the invocation.

Motion by Commissioner Phillips, seconded by Commissioner Holleman to approve the adoption of the agenda for the May 24, 2005 meeting. Passed unanimously.

Motion by Commissioner Holleman, seconded by Commissioner Deal to approve the minutes of the May 3rd & May 12, 2005 meeting. Passed unanimously.

No comments/requests were heard in open forum.

Motion by Commissioner Deal, seconded by Commissioner Holleman to give permission for David Odom to sign the title for the Fire Truck since it was wrecked in the accident on May 23, 2005. Passed unanimously.

Mayor Barriger opened the public hearing regarding the proposed FY 2005/2006 budget for the Town of Taylorsville. No citizens were present for comments. Commissioner Phillips stated that he would like to see the town help support the Chamber of Commerce. He indicated that Alexander County has stated that they will match the Town's support of the Chamber. He suggested a \$4,000.00 allocation out of the current FY 04/05 budget and to allocate \$6,000.00 in the FY 05/05 budget. No other comments were made and the hearing was closed.

Motion by Commissioner Phillips, seconded by Commissioner Deal to approve a budget amendment from the current FY 04/05 budget of \$4,000.00 to the Chamber of Commerce. Passed unanimously. See attachment A, which is hereby incorporated and made a part of these minutes. Passed unanimously.

Motion by Commissioner Phillips, seconded by Commissioner Deal to allocate \$6,000.00 in the FY 05/06 budget for the Chamber of Commerce. Passed unanimously.

Motion by Commissioner Deal, seconded by Commissioner Phillips to allow Forgivin Ministries to hook onto the town's sewer system. Outside tap fees will apply. Passed unanimously.

Motion by Commissioner Phillips, seconded by Commissioner Deal to set a public hearing for July 19, 2005 at 5:15 p.m. in order to hear comments on the voluntary satellite annexation petitions from

Mitzie McCurdy and Alexander County Hwy 16 S. properties. Passed unanimously. See attachment B, which is hereby incorporated and made a part of these minutes. Motion by Commissioner Phillips, seconded by Commissioner Holleman to approve a budget amendment from Powell Bill fund balance for \$6500.00 to offset some un-expected expenses. Passed unanimously. See attachment C, which is hereby incorporated and made a part of these minutes.
