Weatherization services are delivered to:

- Single-family homes
- Multi-family dwellings
- Mobile homes
- Condos (individually owned)

Multifamily homes and condos cannot exceed 4 connected units and/or 5 buildings total on property.

Rentals are eligible for services:

Those renting property can also apply but must have written permission from the landlord before any weatherization services can be rendered.

Landlords may be required to make a small contribution toward work to be completed.

Landlord contribution is waived if the landlord qualifies for weatherization based on his/her income.

They suggest the energy efficiency methods that are the most appropriate and cost-effective for your home, making it warm in the winter, cool in the summer and safe all year long.

Typical Weatherization Services

When the energy audit is complete, a technician will meet with your family to explain how the work will be done. The technician will also inform you of ways you can conserve energy. Typical services include:

- Performing tune-ups and repairs to heating and cooling systems
- Improving health and safety conditions by addressing carbon monoxide levels and combustion safety
- Sealing major air leaks
- Installing insulation in attics, walls, and floors
- Sealing and insulating ducts
- · Installing energy efficient bulbs

Diagnostic Tools Testing the airtightness of a home using a special fan called a blower door can help to ensure that air sealing work is effective. Often, energy efficiency incentive programs, such as the DOE/ EPA ENERGY STAR Program, require a blower door test (usually performed in less than an hour) to confirm the tightness of the house. Who is eligible for Weatherization?

The Weatherization Assistance Program is administered through North Carolina's Department of Environmental Quality. Twenty seven agencies throughout the state deliver the services to eligible residents.

Families with incomes below 200% of the Federal Poverty Level would income qualify for services. In addition, households that have received benefits from SSI, CIP(Crisis Intervention Program), LIEAP or TANFwithin the12 months prior to the date of application are automatically eligible, regardless of income.

Due to the demand for services, eligible applicants may be placed on a waiting list for services.

The Weatherization Assistance Program prioritizes eligible families, serving the elderly, people with disabilities and families with children first.
